 - i. **20/01425/COMIND & 20/01426/LBC2 – The Workshop, Englefield Estate Yard**
Minor changes have been made to the application
The Planning Officer is currently reviewing responses from the relevant statutory authorities
 - ii. **20/01637/FUL – Land adjacent to 10 The Street, Englefield – Change of use to car park**
Application is due to be reviewed by the Planning Committee
A written submission can be provided on behalf of the Parish Council
Those in support of the application can lobby the local Councillor

10. Englefield Community Venue

Cllr Crookes provided the following update:

- Building works are due to be complete November 2020
- A legal structure will need to be put in place to manage and operate the venue, this will take the form of a Charitable Incorporated Organisation
- A business plan will be required to establish set-up and ongoing costs
- A small group of volunteers have been put in place to oversee the initial planning and set-up of the venue

11. Theale Primary School – Parking

- The volume of cars parking along Englefield Road and North Street at school drop-off and collection is risking the safety of vehicles, cyclists and pedestrians
- Vehicles trying to join the kiss & drop off arrangement from both directions is also causing an issue
